Happy New Fraternal Year My Brothers, I am excited to be on this journey with you. Again, thank you for your confidence in me to serve as your State Deputy. I would like to recap some of the items covered at our Organizational Meeting in Colorado Springs. Let me begin with our logo. It was, in itself, a journey for me to settle on the image as well as the wording. Basically, it contains a bit of the spirit of every State Deputy I have had the privilege to serve from Jim Conlan to Jay Doherty. It also recognizes the presence and unifying influence of the Holy Spirit in the decisions and workings of the State Council.

The lessons they imparted through their logos have shaped how I will lead. They have shared with us the desire to be peacemakers, devotees of Mary, receivers of the Holy Spirit, champions of the family and shepherds of each other. It is time for us to take those lessons and put them into action and trust the guidance of the Holy Spirit, thus the two imperative statements; Journey with the Spirit, Spread the Gospel by words and works.

We must evaluate these conditions, adapt and overcome. This means change.

We must undergo a culture change in order to attract and keep members. We must offer new and different programs to attract younger family and faith seeking men. Studies show that men under 40 want to join organizations that share their priorities. I ask all leaders to recognize the need for change and that complacency and resistance to change must give way to a culture of change. I call upon all Knights to be the change we need. How do we start? Oddly enough we must go backwards in time to 1882 and review the reason Fr. McGivney started the Order. What was his vision? What is our mission?

One key change strategy is to fully implement the mission-centric model of Faith in Action which is designed to offer men/members and their families the opportunity to: grow in their faith, engage their families in mission, serve their parish and community, defend the dignity of human life and evangelize through action.

Let me close by saying, we are Knights of Unity, we are in this together. United in action to reverse the decline in membership and enrich our members and families will bring new life to all councils. Don't let the words of our ceremonials be silent, give them life through your actions. Imitate the Apostles, walk the road of faith knowing the Spirit is with you.

#### A MESSSGE FROM THE STATE ADVOCATE

As we begin to settle into a new fraternal year and our roles as newly elected, re-elected, appointed or re-appointed council, district and state officers, we've discovered our positions bestow on us certain specific authorities and duties. We are fully vested, through the Laws and Rules of the Order and council and state bylaws, with the power to exercise the authorities of our respective offices. How we use that authority to guide, direct, mentor and serve those Knights and families who willing follow us will testify to our ability as leaders.


Much has been written about leadership and of those whom we perceive or recognize as great leaders. There are many traits of leadership, such as: honesty, competence, humility and courage to name a few. Leadership, like being a parent, isn't about being a friend, popular or even being well-liked. It's about mutual respect and more importantly, service to those entrusted to our care.

Jesus calls us to be servant-leaders. Father McGivney, our venerable founder, left us the legacy on how to be a servant-leader. His legacy to us is principles of fraternalism with the challenge to live these principles in service to God and neighbor every day of our lives. The principles of: Charity, Unity and Fraternity embody every principle of leadership ever written and provide the simple prescription of how to serve others.

As newly or re-installed Grand Knights and Advocates, I encourage each of you to study. Study the Laws and Rules of the Order, your local council by-laws, home corporations guidelines from Supreme (if applicable), Robert's Rules of Order and Safe Environment. What do the Laws and Rules mean? What obligations do they impose? Are there exceptions to the laws and rules and under what conditions? What are our duties under the laws and rules?

As Knights, we are called to dutifully uphold the laws and rules of our Order and the tenants of our faith. The Order's principles of charity, unity, and fraternity should always guide the exercise of our authority. These three principles underlie the laws of the Order and presuppose that all members of the Knights of Columbus, as Catholic gentlemen, will follow these fundamental principles. Unfortunately, at times, we are called to deal with issues relating to behavior that is inconsistent with the principles of the Knights of Columbus and the teachings of our church. Our approach should be to privately and informally talk to the individual member in person and, with a charitable spirit, discuss the matter and provide advice and counsel. If this proves ineffective, our next step should be to address the matter at the local council level, then at the state council level, and only then at the Supreme Council. Officers should be able to resolve the vast majority of issues and problems by speaking directly with the Brother Knight or by working with the Brother Knight's Grand Knight and/or chaplain. Officers should be a calming influence against the rash judgments of those whose first impulse may be to disregard the principle of due process and summarily suspend and expel a member from the Order without affording their Brother Knight an opportunity to offer an explanation or to clear up any misunderstanding or to otherwise resolve an issue in private. Officers should not resort to formal disciplinary action unless and until all other reasonable attempts to resolve a situation have been exhausted. Never hesitate to contact the State Deputy of myself with any questions.

In my last article I had nothing definitive as to the deadline for the old regalia. As many of you know from my last copies of Supreme memos, I do now. The old regalia, as of midnight June 30, 2019, wearing of the old regalia comes to an end. I will be providing information at the Organizational meeting 4th degree breakout session concerning procedures, rules and operational guidelines for FN's, CCC's and Marshals. If you are in one of these positions, please try to attend the session. If you cannot make it, please send someone in your place. A short synopsis of the guidelines includes:

- 1. Honor Guards for official functions are in the new uniform only.
- 2. Utilizing 4th degree members in tuxedos with either social baldrics or service baldrics and swords for Honor Guards are not permitted. Only new uniforms for Honor Guards.
- 3. No authorized use for old regalia.
- 4. First offense for wearing old regalia is denied participation in event and a written warning. Copies to Master and on file at assembly.
- 5. Second offense is denied participation in event, denied participation in any Honor Guard for remainder of fraternal year, written warning. Copies to Supreme, VSM, Master and on file at assembly.
- 6. Third and subsequent violations subject to summary suspension.

I realize that this is a very emotional time and the time of the change is upon us. Whether we like it or not, each of us has had a two year period to come to a decision. During that time, other than many unsubstantiated rumors, Supreme did not indicate that there would possibly be another extension and the plan was for a deadline of June 30, 2019. We will probably be a little short on the size of Honor Guards for some time, but I would encourage assemblies to partner up and assist those parishes who may want an Honor Guard but their assembly is unable to field an adequate group. Practice the principle of Unity and work together. Though this change seems huge to some, it is cosmetic in nature as nothing has changed in the substance of our Order and the principles for which it stands.


